### 'Annexure-I' (Eligibility Criteria)

- The bidder must be a company registered under Central Pollution Control Board or Gujarat Pollution Control Board for disposal of E-waste and other obsolete furniture's and must submit registration certificate for the same.
- Copy of PAN Card, GST Number Registration Certificate & Aadhar/ Address
  Proof in the name of proprietor/owner/firm/ company is required to be
  submitted. The documents submitted should be legible. In case the documents
  are not readable, the bid cannot be examined, and the bid can be rejected,
  thereby rejecting the bid of that firm.
- 3. The bidder should deposit Rs. 8000/- (Rupees Eight thousand only) as EMD in the form of Demand Draft or Pay Order in favour of "Pay and Account Officer, CBIC" payable at Vapi. Offers received without required EMD will not be accepted and shall be rejected at the tender opening stage itself. EMD of the unsuccessful bidder shall be returned without interest at the earliest on finalization of the auction.
