**TRADE NOTICE- 01 /2020, DATED 15.07.2020**

Attention of Trade Associations, Chambers of Commerce and all the stake holders is invited to Dadra and Nagar Haveli and Daman and Diu (Merger of Union Territories) Act, 2019. The Department of Revenue, Govt. of India, in compliance with the above Act, has notified 31st July, 2020 as the effective date of migration of taxpayers for GST Compliance requirements, vide notification No. 10/2020 – Central Tax dated 21<sup>st</sup> March 2020 read with notification No. 45/2020 – Central Tax dated 9<sup>th</sup> June 2020.

It was decided by the GST Council to give 26 as the state/ union territory code to the merged Union Territory of Dadra and Nagar Haveli and Daman and Diu. Therefore, all the GSTINs containing UT Code 25 in erstwhile union territory of Daman and Diu shall be migrated to UT Code 26 w.e.f. midnight of 31st July, 2020 and all GST related compliances shall be undertaken with UT Code 26 only from 1st August, 2020 onward.

The GSTINs with UT Code 25 shall be marked as cancelled w.e.f. 31st July 2020 onward. However, these old GSTINs shall remain operational for GST related compliances pertaining to the period prior to 31st July, 2020.

All existing active taxpayers having GSTIN with UT code 25, will be given new GSTIN with UT Code 26 along with login credentials at their email of Primary Authorized Signatory.

The new UT Dadra and Nagar Haveli and Daman and Diu shall have following districts in the dropdown:

(1) Union territory jurisdiction Code - 26

(2) Name of the Districts of Dadra and Nagar Haveli and Daman and Diu (UT Code-26)


